Mr. Mike Hester, 2908 S. Crums Lane, complained about drainage problems which has been on going for 16 years because they are on septic tanks but if it is voted on, they may get sewers. He also brought in pictures of the drainage problem.

Mayor Conner asked John Haywood could we do anything to help?

John Haywood, Works Director said he would take a look at it.

Mayor Conner then presented the city council with the budget and said it has been prepared to include paying the police and fire building off. She would like for the city council to look over it and the first week in June we will have the first reading.

Mr. Charles Stinson. 1861 Lynn Lea Road, said there are a lot of people coming through by the ditch in behind his house and someone moved the screens on his back window over in order to try and break in and he called the police but because nothing was stolen he didn't file a report. He just wanted to let them know this happened. Lastly he said the drainage in the front yard needs to be cleaned again.
