Mitzi Kasitz, City Clerk then read the following proclamation:

**FIRE PREVENTION PROCLAMATION
OCTOBER 4TH THRU 10TH**

WHEREAS, THE CITY OF SHIVELY IS COMMITTED TO ENSURING THE SAFETY AND SECURITY OF ALL THOSE LIVING IN AND VISITING OUR CITY: AND

WHEREAS, FIRE IS A SERIOUS PUBLIC SAFETY CONCERN BOTH LOCALLY AND NATIONALLY, AND HOMES ARE THE LOCATIONS PEOPLE ARE AT GREATEST RISK FROM FIRE: AND

WHEREAS, ROUGHLY 3,000 PEOPLE DIE AS A RESULT OF HOME FIRES AND BURNS, MORE THAN 200,000 INDIVIDUALS ARE SEEN IN THE NATIONS EMERGENCY ROOMS FOR BURN INJURIES: AND

WHEREAS, THERMAL BURNS OUTNUMBER SCALDS NEARLY TWO-TO-ONE, BUT FOR CHILDREN AGES FIVE AND UNDER SCALDS OUTNUMBER BURNS ROUGHLY TWO-TO-ONE: AND

WHEREAS, COOKING IS THE LEADING CAUSE OF HOME FIRES AND HOME FIRE INJURIES, WHILE HEATING EQUIPMENT AND SMOKING ARE THE LEADING CAUSES OF HOME FIRE DEATHS: AND

WHEREAS, THE CITY OF SHIVELY'S FIRST RESPONDERS ARE DEDICATED TO REDUCING THE OCCURRENCE OF HOME FIRES AND HOME FIRE INJURIES THROUGH PREVENTION AND PROTECTION EDUCATION; AND

WHEREAS, THE CITY OF SHIVELY'S RESIDENTS ARE RESPONSIVE TO PUBLIC EDUCATION MEASURES AND ARE ABLE TO TAKE PERSONAL STEPS TO INCREASE THEIR SAFETY FROM FIRE, ESPECIALLY IN THEIR HOMES: AND

WHEREAS, RESIDENTS WHO HAVE PLANNED AND PRACTICED A HOME FIRE ESCAPE PLAN ARE MORE PREPARED AND WILL THEREFORE BE MORE LIKELY TO SURVIVE A FIRE: AND

WHEREAS, THE 2009 FIRE PREVENTION WEEK THEME, "STAY FIRE SMART! DON'T GET BURNED" EFFECTIVELY SERVES TO REMIND US ALL OF THE SIMPLE ACTIONS WE CAN TAKE TO STAY SAFE FROM FIRE DURING FIRE PREVENTION WEEK AND YEAR-ROUND.

THEREFORE, I SHERRY S. CONNER, MAYOR OF SHIVELY DO HEREBY PROCLAIM OCTOBER 4TH – 10TH 2009, FIRE PREVENTION WEEK THROUGHOUT THE CITY OF SHIVELY, AND I URGE ALL CITIZENS OF SHIVELY TO PROTECT THEIR HOMES FAMILIES BY HEEDING THE IMPORTANT SAFETY MESSAGES OF FIRE PREVENTION WEEK 2009, AND TO SUPPORT THE MANY PUBLIC SAFETY ACTIVITIES AND THE CITY OF SHIVELY'S FIRE AND EMERGENCY SERVICES.
